Persons empowered to perform a marriage ceremony are required to send a notification of a marriage to Registers Iceland, Þjóðskrá Íslands, Borgartúni 21, 105 Reykjavík.

Accompanying documents for the Certificate of Examination of Impediments to Marriages should not accompany the notification unless in the case of foreign nationals, who are required to send a photocopy of their passports.
